

PROFILE

I have twenty-five years of experience in research, teaching, executive training and advisory on Business Ethics, Sustainability Management and Reporting, and Corporate Social Responsibility (CSR). I have taught courses on these topics in Italy (Universities of Verona, Torino, Bergamo, LIUC-Castellanza, Milano-Statale, Milano-Bicocca and Bologna), Switzerland (Univ. of Geneva), Ireland (DCU, Dublin), Germany (Kempten Univ. of Applied Sciences), Austria (Univ. of Salzburg), Slovenia (IEDC School of Management, Bled), France (GEM-Grenoble; UCO Angers, BSB Dijon, IÉSEG Paris & Lille), United States (University of Virginia), Vietnam (CFVG Hanoi & CFVG Ho Chi Minh City) and United Arab Emirates (NYU Abu Dhabi).

At IÉSEG since 2014 I teach Business Ethics, CSR and Sustainability courses to undergraduate and graduate students. In 2016 I designed the new Business Ethics course (16-hour, 2 ECTS) that is compulsory for all IESEG Grande Ecole students, coordinating a team of nine professors. I also introduced two new Executive MBA modules on "Developing a Sustainability Mindset" and "Sustainability Metrics", a course on "Business Ethics and Corporate Responsibility" in 4 different Master programmes, and an elective called "Responsible Leadership" that includes several applications of ethics to managerial decision-making processes, including one class dedicated to Ethics & Artificial Intelligence.

In 2010 I obtained my PhD in Management and Business Ethics at the **Darden School of Business**, University of Virginia, with <u>R. Edward Freeman</u> as advisor (the world's leading thinker in the field of Business Ethics with more than <u>117,000 citations</u> on Google Scholar). Since then, I have regularly been a Visiting Scholar at Darden, leading to six publications with Ed Freeman and other ongoing projects with him and other Darden colleagues.

I am a co-author of <u>Stakeholder Theory: The State of the Art</u> (Freeman et al., 2010, Cambridge University Press), a reference publication in stakeholder theory, having received more than <u>5,000 citations</u>. I have published my research in top academic journals, including the *Academy of Management Annals* (ABS Academic Journal Guide 2021: cat. 4) and four articles in the *Journal of Business Ethics* (ABS cat. 3). I have presented my research at more than <u>sixty conferences</u> worldwide.

I am a passionate tennis player and love to play the piano in my free time. I live in Paris but still spend every summer in Negrar di Valpolicella (Verona), my hometown.

In a nutshell, my research approach focuses on the concept of <u>Responsible Capitalism</u>, or a new way of conceiving business fully embracing stakeholder theory. In particular, I am interested in exploring the <u>antecedents</u> (e.g., Moral imagination) of ethical decision-making within organizations; understanding the role of stakeholder relationships in the value creation process; and developing the managerial mindset and tools (e.g., Artificial Intelligence, but also Theatre and the Arts) that can facilitate the transition towards more responsible and sustainable organizations.
